Physical Education Spotlight/Reminder

The goal of The Howard County Public School System's Physical Education program is to help prepare students for college and career readiness by developing physically-literate individuals who have the knowledge, skills, and confidence to enjoy a lifetime of healthful physical activity. Students are encouraged to question, integrate, analyze, communicate and apply cognitive, psychomotor and affective concepts helping them gain a wide multicultural view of the world through physical education learning experiences. It is our hope that through positive experiences students will value physical activity and acknowledge its contributions to a healthful lifestyle.

An important and part of the physical education program focuses on safety. To that end, it is important that all students wear clothing and footwear that allows for safe and free movement. The following should be adhered to:

• Appropriate athletic and supportive footwear is needed for safety, protection, and performance. Students should wear an athletic shoe with a non-marking molded rubber sole. Heeled sneakers or fashion style sneakers are not acceptable. Sneakers need to be on, laces tied and/or velcroed.

- Appropriate athletic clothing that allows for free and safe movement.
- Nothing around or on the:
 - Neck (necklaces, lanyards, garments)
 - \circ Wrist (watches, bracelets)
 - Hands (gloves, rings)
 - Ears or head (earrings except for stud earrings, hard sharp hair holders)
- No dangling clothing (scarves or clothes that are baggy).
- Jewelry should not be worn during physical education class with the following exceptions:
 - Stud earrings are permitted.
 - Medical alert bracelets/necklaces are permitted if they have a break away feature that allows it to be easily removed during an emergency situation.
 - Religious bracelets/necklaces are permitted if they have a break away feature that allows it to be easily removed during an emergency situation.
- No food products in the mouth.

Title I Information

Did you know that our school receives resources from Title I? Title I, Part A is contained in the Every Student Succeeds Act (ESSA), which was signed into law in 2015. This legislation reauthorizes the 50year-old Elementary and Secondary Education Act (ESEA). Title I, Part A is a federal program that provides financial assistance to local school systems and schools with high percentages of poor children to support the academic achievement of disadvantaged students. All twenty-four local education agencies in Maryland receive Title I funds. These funds provide additional academic support and learning opportunities to help low-achieving children who attend Title I schools master challenging curricula and meet state standards. Title I funds support extra instruction in reading and mathematics, additional teachers, materials of instruction, as well as after-school and summer programs to extend and reinforce the regular school curriculum. BSAP Saturday Math Academy

The Howard County Public School System's BSAP Saturday Math Academy (BSAP-SMA) has been in existence since 1992. The program was developed in collaboration with the HCPSS and parents as a response to requests for opportunities to network. The priority was to learn instructional mathematical strategies to support their children at home and to accelerate academic achievement.

Certified teachers work with a diverse population of students on all levels of mathematics. Teachers assess student levels before placement in classes and plan accordingly. In addition to receiving weekly instruction, students have multiple opportunities to engage in STEM related activities such as robotics and MESA (Math, Engineering, Science Achievement) and 30-minute chess instruction which is taught by chess tutors and community volunteers.

The BSAP Saturday Math Academy is open to all students in grades 3 – 12 in the Howard County Public School System. Students must be registered in order to attend the fall or spring sessions which meet on Saturday mornings from 9:00AM – 12:00PM at Oakland Mills High School.
